THE YOUTH BARISTA PROGRAM GRADUATED 55 YOUTH, PLACING 75% IN JOBS WITHIN 6 MONTHS. 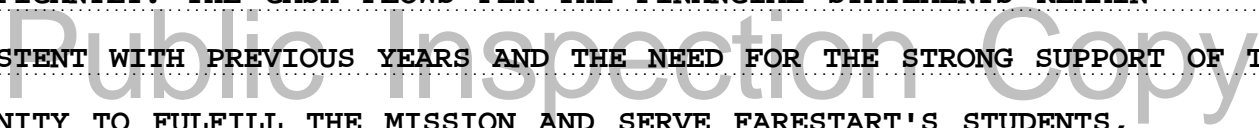
