YOUTH BARISTA & CULINARY PROGRAMS

FareStart gives youth the opportunity to succeed by giving them hands-on culinary and barista training in our cafes, along with customer service, life skills and job placement assistance. We partner with Seattle Public Schools Interagency Academy for our culinary program and YouthCare for our barista program.

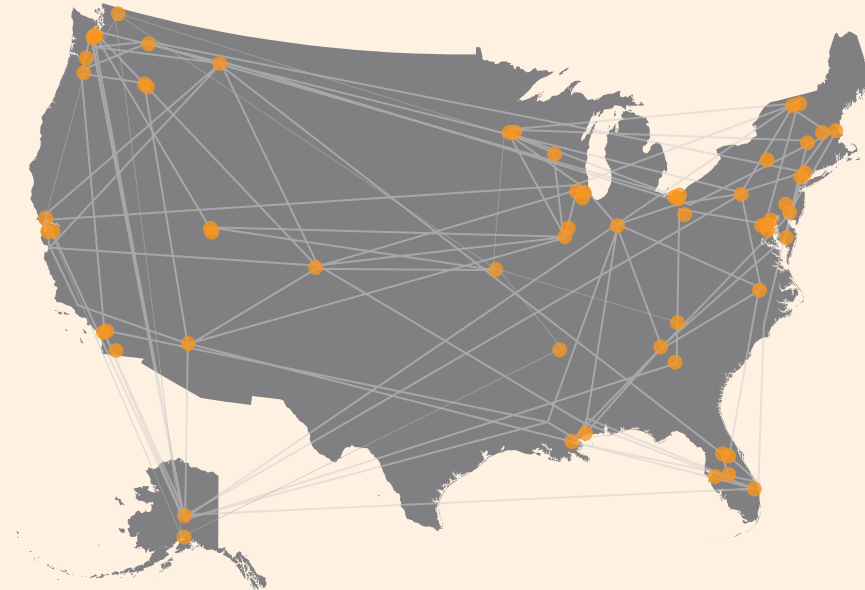

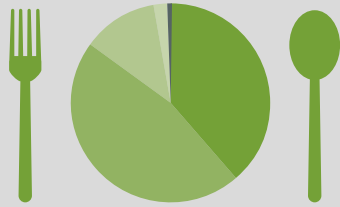

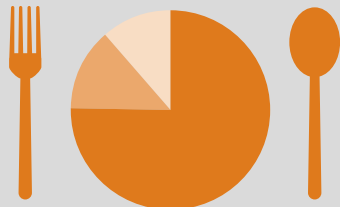
